2. **University may book the expenditure under Plan separately for General Component, SC Component, ST component and furnish the Statement of Expenditure / utilization certificate accordingly.**
3. The sanctioned amount is debitible to the major head 1 A (i) (e) (g) (h) 31 as per details given above and is valid for payment during the financial year 2012-2013 only.
4. The grant shall be utilized by the University for Grant in aid General.
5. The amount of the Grant shall be drawn by the Under Secretary (Drawing and Disbursing Officer) UGC on the Grants-in-aid bill and shall be disbursed to and credited to the **Registrar, University of Delhi, Delhi - 110 007** through Demand Draft/Mail transfer.
6. The Grant is subject to the adjustment on the basis of Utilization Certificate in the prescribed Performa submitted by the University/College/Institution.
7. The Utilisation Certificate to the effect that the grant has been utilised for the purpose for which it has been sanctioned shall be furnished to the UGC as early as possible after the current financial year.
8. The assets acquired wholly or substantially out of University Grants Commission's Grant shall not be disposed or encumbered or utilized for the purposes other than those for which the grants was given without proper sanction of the UGC and should at any time the University ceased to function, such assets shall revert to the University Grants Commission.
9. A Register of Assets acquired wholly or substantially out of the grant shall be maintained by the University in the prescribed form.
